#### **COMMITTEE REPORTS:**

Supervisor Kniffen reported he attended a quarterly meeting with the Broome County Executive. He noted that the County did get the election budget reduced. In regard to the sale tax, he explained that it has been a long time since the split has been 50/50 between the County and the towns and villages. Debbie Preston pledged to get that back to 50/50 but it has been a struggle with the tax cap and all that has been going on. The tax cap was originally 2% but now it is related to the inflation rate, whichever is lower. For next year it is .76, which is <sup>3</sup>/<sub>4</sub> of a percent by which taxes can be raised. With the sales tax, under the current plan how it is distributed, is to take the difference between how they distribute it now and if it was 50/50 what the difference would be and give the towns and villages 20% of that. For next year Debbie said she will give the towns and villages 30%.
