**COMMITTEE REPORTS:**

Councilman Diffendorf reported at the annual PERMA meeting he attended the Town received an award for 20 years of continuous service with PERMA as well as a Timely Claims Filing Certificate since all claims have been submitted within the 10-day limit.

Councilman Grubham said he had some issues to discuss but he will wait until Ray Coolbaugh is in attendance. He noted the issues are in regard to the veterans' memorial, gazebo roof and tennis courts. He said the tennis courts are cracking and should be taken care of since the Town spent money redoing them a few years ago.

Councilman Weingartner reported that according to Christina Radicchi all coaches do have keys to access the defibrillators located in the parks.

Supervisor Kniffen reported that in 2006, after the first catastrophic flood in our area, then Senator Clinton and Senator Schumer sponsored a \$30 million study of the Susquehanna River Basin and now 10 years later nothing has been done. Kirkwood has been staying in touch with Schumer's office, the Army Corps of Engineers, and whoever else would listen. There was a reconnaissance study done for \$100,000, but he does not know what was

accomplished. \$3 million has been appropriated for the Army Corps to go ahead with a feasibility study. However, before they could do it, they needed a co-sponsor, and NYSDEC has agreed to that. Probably within the next month there will be an official announcement that this will get started. Although the amount is \$3 million, the initial outlay will be \$600,000. Supervisor Kniffen's understanding is that they have to complete the feasibility study within 3 years. If there is some remediation that can be done then more funding will be needed for that to actually happen, which is years off too. He said it is frustrating and although there may be some light at the end of the tunnel is taking a lot of time and he is very sorry for that.

**OLD BUSINESS:**

**Discussion – Solar Energy Public Hearings - May 31, 2016.**

Supervisor Kniffen explained that two public hearings were held last week regarding solar energy. The Board has been going to seminars and doing whatever they can to learn more about it. Since they do need to learn more they thought it would be a good idea to have a one year moratorium. Also, unless the Board does something about it, anyone who has solar panels has a tax exemption for 15 years, so a public hearing was held to revoke that exemption in Kirkwood. These issues are on this agenda for a resolution but since last week the Town's law firm noted a concern with the wording of the resolution for the moratorium, being mindful of when Binghamton did that with a natural gas drilling moratorium they were sued and they lost. The legal department feels they should re-hear this and include a 239 review by Broome County. Mr. Begeal said it would give his firm time to do more research and submit to the proper County review so that isn't one of the things that the Town could be challenged on. Councilman Grubham said the Board processes a lot of resolutions and very seldom do they include the County and he questioned why they should be included now. Mr. Begeal said not all local laws need to go for County review but he believes land use moratoriums have to. He added that it's different from a police powers moratorium which is when a moratorium is done because something is imminent as an emergency and something has to immediately be stopped so it doesn't harm people or property. He said they believe the moratorium they are dealing with is for the purpose of updating the zoning before it is allowed to happen in Kirkwood and 239 review is probably required. Councilman Grubham questioned what would happen if someone wants to put a in a solar farm and they go to the Town's Zoning Board of Appeals for a variance. Mr. Begeal said that would take some time and he feels the worst case scenario would be adopting a moratorium at next month's meeting. Mr. Begeal compared this to fracking. At that time they said if it's not a permitted use in the district that they want to do it in, it is more than likely they are not allowed to do it. At this point it is the same issue for solar, if someone wanted to put in a solar farm and it is not listed as a permitted use within the district they probably can't do it anyway. The zoning would need to be updated if the Board wants to allow it as a permitted use in a certain area. More than likely someone is not going to start the process for a solar farm since it is not a permitted

use and even if they did they would have to get a variance which would take a while. Councilman Grubham noted a concern that once a variance request is made they can't stop it with new rules. Mr. Begeal said the applicant would probably be grandfathered in with respect to the zoning, but a moratorium would be fine to pass at that point because it is just putting a halt on everything. Councilman Diffendorf questioned what would happen if the County says no. Mr. Begeal said although they could, he doubts that they would. The scope of their review is strictly restricted to whether there is going to be any significant inter-community environmental impacts. By virtue of a moratorium the Board would be saying no one can do anything. So there can't really be an environmental impact based on saying you can't do something. Supervisor Kniffen said the Board would have to wait to see why the County would be negative, because there is no way of knowing at this point. Councilman Diffendorf noted a concern that this wasn't brought to them sooner. He said his take on this is that since the last meeting someone has gotten into someone's ear about this. He added that he is comfortable with passing it now. Councilwoman Yonchuk questioned with submitting it to Broome County if it is likely the Board would be able to act on it next month. Mr. Begeal said technically the Board has to have the 239 results back before the close of the public hearing so the public can see the response from the County before their opportunity to speak. It was noted that due to the summer schedule of combining meetings the next meeting is June 27<sup>th</sup>. Mr. Begeal said the County has a maximum of 30 days to respond but in his experience they usually get it done quicker than that and this sort of review should not take a lot of time. After discussing this with his colleagues, Mr. Begeal said they are just cautioning the Board that they could get challenged on this if they don't get the 239 review. In response to Councilman Grubham, Mr. Begeal said that yes, if they get challenged they could go ahead and get the 239 review and do the whole process over. He said that the problem though would be that if they did it and relied upon it and a developer saw that it was done wrong, they could just go forward with the process and challenge it and then the moratorium would be unenforceable. Councilman Diffendorf said there currently is no zoning for it. He noted that Dryden banned fracking because they didn't have zoning for it. He said Mr. Kline always told the Board they could never ban anything, that there always had to be a place for it, but they have found out since with the New York State government things can be banned through zoning. Supervisor Kniffen said he feels by holding it for one month the only exposure they would have is if someone comes in during that time and asks for a variance from the ZBA. He questioned if the ZBA, knowing full well the Town Board wants to have a moratorium but are not to that point yet, could use that in their decision. Mr. Begeal said, yes, he would advise them to hold off on making a decision. Supervisor Kniffen said he feels they should do it the right way and have another hearing in a month. Councilman Diffendorf still noted a concern and said he wants to go ahead with the moratorium. Supervisor Kniffen said he does not feel they should ignore the additional information they have received.

**Discussion:** Councilwoman Yonchuk said there are people that have put solar panels in their homes and she questioned if they currently are tax exempt. Mr. Begeal said the exemption would just apply to the increased assessment as a result of the solar panels. Supervisor Kniffen questioned how this would work for them. Mr. Begeal said this will have to be looked at. Councilman Diffendorf said people with solar panels had to apply for the exemption, this is not automatic. He said the Assessor said no one in Kirkwood has ever asked for the exemption. Supervisor Kniffen said the Assessor told him they are assessed and told him the formula he used to do it, but said they are tax exempt anyway since the Board has not done anything. Mr. Begeal said his understanding is that people have to file for the exemption. Councilman Weingartner said because of the minimal amount of assessment going up this is geared more towards the big solar farms. That would increase the value of the property and that is his understanding as to the reason for doing this. Councilwoman Yonchuk said for those residents who may have already put solar panels in their homes and would be entitled to the exemption, albeit not on the scale of a solar farm, the Board is taking something away from them unless they are grandfathered and unless they have the exemption, which does not seem clear. Although Supervisor Kniffen suggested rewording the resolution to exclude residential, Mr. Begeal said they cannot do that, it is all or nothing. He said the way to carve out is to not adopt the opt out and put the PILOT in place for the big ones the Board would want to tax. He added if the Board decides not to opt out what would normally happen is for the big solar projects, within 60 days of them signing a contract to put this in place, they would have to give notice to the Town and within that 60-day period the Town would have to decide whether or not they want to put a PILOT in place. Supervisor Kniffen questioned why they would want a PILOT if they are tax exempt. Mr. Begeal said the Board would have the ability to put a PILOT in place and the company would be forced to do it. This is the case only when they are tax exempt. If the opt out is adopted then there is no PILOT option and they would be fully taxable. Councilman Grubham said all this tells him is this is exactly why they need a moratorium because there are so many unanswered questions. If there is a moratorium this could wait because no one will be doing it anyway. There would then be time to determine if there is a better way to do this. Councilman Weingartner suggested they hold this resolution and proceed with the resolution dealing with the moratorium. He said although it is not a huge amount of money they would save on their taxes, if there is an exemption, the Board can't just carve out who they want to exempt. **Resolution Held.** (Note: Since this proposed Local Law No. 4-2016 was held, the following proposed Local Law will assume that number.)

**Discussion:** Councilman Diffendorf said he wants to be sure what they are actually voting on with this resolution regarding health and dental insurance. Supervisor Kniffen said in regard to 4.) Eligibility for Coverage into Retirement, since the 1990s the retirement age to get health insurance was at 2 levels – 15 to 19 years and age 55 that a person would be eligible for just individual coverage and if a person had 20 years or over at 55 years of age they would get whatever they got as an active employee, whether it was a family, 2-person or individual. The change will eliminate the 15 to 19 years and make the retirement age 62, and at 20 years of service a person would be entitled to whatever coverage they had as an active employee. Councilman Weingartner questioned if at age 62 they would be eligible for the coverage they received as an active employee at the same contribution percentage they paid as an active employee. Supervisor Kniffen said the way he reads it he does not believe any retiree contributes once they retire. This only actually gives them 3 years of 100% insurance because at 65 the Town no longer insures them and they go into the Medicare pool which is \$2,400 a year for them and their spouse. Councilman Weingartner said that because of a concern he had with the retirement age for new employees coming in, he verified that it is 62. Supervisor Kniffen added this is retroactive

back to May 3<sup>rd</sup>. Councilman Diffendorf said he still has a concern with the coverage in this section for Mr. Kline.

Councilwoman Yonchuk moved to adopt resolution amending the Town of Kirkwood Benefit Plan effective May 3, 2016 as follows:

**Additional Discussion:** Councilman Grubham questioned if there is a way of examining the costs and/or savings involved with these changes. Supervisor Kniffen will get those figures. He added that this is part of the Board being proactive. He said changes were made in the past when in the 1990s an employee could retire with 5 years of service and they went to what they currently have, and he feels this saved the Town over a half million dollars. He said they cannot continue to pay the high medical costs that increase 12% to 15% a year, noting they would go broke at some point.

Resolution appointing Chad Moran Building & Code Inspector-OC of the Town of Kirkwood on a probationary status effective June 8, 2016. Supervisor Kniffen questioned the wording of this resolution. **Resolution Held.**

**Discussion: Mowing of Vacant Properties – 114 Ostrum Road, 47 & 23 S. Sunset.**

Supervisor Kniffen explained when the previous Code Officer was with the Town there were properties that were in foreclosure and the Code Officer went out on his own and had someone mow and do other things on the properties with no input from the Board but they received the bill. Chad Moran is now looking for some direction with properties in the same situation, with the grass not being mowed, etc. Supervisor Kniffen added the last time the bill was about \$4,000, it was put on the tax bill and the County has since reimbursed the Town for the total amount. Supervisor Kniffen said it should go to bid. Councilman Weingartner questioned why town employees can't do it and keep track of the hours and charge them back for it. Bill Tozer said currently they are short staffed. Councilman Grubham said it's such a small item he doesn't see the need to go out to bid. Supervisor Kniffen did note that although the County reimbursed the Town the \$4,000, at some point if the County does not get the money back they might ask the Town for

reimbursement. In response to Councilman Grubham, Supervisor Kniffen said he is not sure if there have been complaints on the properties or if Chad has just observed them himself. Councilman Grubham said it is in the Code how to handle complaints and if they don't get handled he is questioning how they avoid that situation. Supervisor Kniffen said it's different if someone is actually living on the property than if it is vacant. The Code Office can take them to court. These properties either are tax properties or are in the process of being tax properties. This will be held for more input from Chad.
