## **COMMITTEE REPORTS:**

## **Cedarhurst Road – Sink Holes.**

Councilmember Diffendorf reported about a section of Cedarhurst Road where a large culvert pipe runs underneath the road and sink holes are forming along the edge of the road. He suggested having an engineer look at it, he is concerned that something is going on under the ground and the pipe will wash out, causing a safety issue for anyone using the road. Poe Williams explained it's been looked at by himself and his crew and he intended to put flowable fill on the bottom of the pipe and then seal the top as well, so the sink holes don't continue, he noted the bottom of the pipe is completely rotted out. About eight bags of Sakrete have been dumped in there and Poe Williams has been driving by to check it daily. It was agreed to put the flowable fill in there and have John Mastronardi, Town Engineer, follow up on the situation.

## Route 11 Water Line Break – Near the State Line.

Councilmember Diffendorf mentioned his concern about how a recent break in the water line was handled by the Public Works Department on Route 11 near the state line. He noted the equipment was left at the scene overnight and extremely close to the road, and there were not enough flashing lights to warn drivers, it was very dangerous. He suggested plating the hole next time. He said it can't be done that way ever again.

Poe Williams explained that he took care of the situation as soon as he received the call from Councilmember Diffendorf. He was able to get more flashing lights on hand. He didn't want to keep the guys out there all night, but next time he will handle it differently. He reminded the Board that he is new at this job and trying to do the best he can.

## **Community Clean Up Day.**

Councilmember Wasson reported that Community Clean Up Day in April had a good turnout, she noted more people participated this year than in the past.

## **Fire Stations – Open Houses.**

Councilmember Wasson recognized the Kirkwood Fire Companies for the Open Houses they ran in April for recruitment purposes. Main Street had someone sign up to become a new member.

Lastly, she invited everyone to the Kirkwood Historical Society next Tuesday, May 13, 2025 at 5:30 PM to hear Roger Luther, Broome County Historian, speak about the Castle located on the State Hospital property.
