## **1.0 INTRODUCTION**

This Consolidation has been prepared as required under Article 17-A, Title 2 of the General Municipal Law, Consolidation and Dissolution of Local Government, where its purpose is to assist Town officials and residents in evaluating the public benefit of consolidation of the existing Sewer District 1, Sewer District 1 - Ext. 1, Sewer District 1 - Ext. 2, Sewer District 1 - Ext. 3, Sewer District 1 - Ext. 4, Sewer District #2, Sewer District #3, Sewer District #4, Sewer District #5, Sewer District #6, and Sewer District #7, into the Consolidated Sewer District as these districts currently convey wastewater to the main sewer station, thereby creating a common cost base.

### **1.1 Background**

The Town of Kirkwood, Broome County, lies on the Northern side of the Susquehanna River and extends from the Pennsylvania Border to the city limits of Binghamton, NY. The Town owns, operates and manages eleven (11) sewer districts (SD) where wastewater is collected via an estimated 25 miles of Town-owned sewer lines including gravity and force mains with a total of nine (9) pump (lift) sub-stations and one (1) main pump station. The main pump station ultimately discharges to the City of Binghamton sewer collection system therefore the Town of Kirkwood is classified as an outside user to the Binghamton-Johnson City Joint Sewage Treatment Facility.

The eleven districts are made up of a mix of residential, commercial, industrial and institutional property uses with a combined total of 708 users with 5998.39 assessed sewer units.

A map identifying the existing Sewer District boundaries is included in Appendix A. A map of the proposed Consolidated Sewer District is included in Appendix B.

### **1.2 Reasons for Project**

At the time of their creation, each of the eleven sewer districts had a purpose, and separating their revenues and expenses made sense. However, it was always the Town Board's intention to one day consolidate the districts. At this time, no new sewer districts are being considered, therefore, the timing for consolidation is optimal. It is important to note that the Town's water districts were combined into one Consolidated Water District approximately twenty years ago.

The current sewer infrastructure is arduous to manage from an administrative perspective, as well from a capital planning and budgeting perspective. The methods for allocating expenses among the eleven districts varies depending upon the nature of the charge. If there is a Binghamton-Johnson City Joint Sewer charge, then flow is used to determine the allocation. If there is an operational charge, then benefit units are used to determine the allocation. This can be both confusing and time consuming when charges have to be split eleven ways.

Administrative, capital planning and budgeting processes would all benefit substantially from the consolidation of the sewer districts. The financial reporting alone for the eleven districts is complex for the administrative staff to manage and for the Town Board to digest. The proposed consolidation would streamline the reporting, which would result in timelier reporting to the Town Board.

## **2.0 DESCRIPTION OF EXISTING SEWER DISTRICTS**

### **2.1 Sewer District #1**

Sewer District #1 was the first district formed in the Town. The SD serves the Five Mile Point area, Industrial Park, US Route 11 from Sunset Lanes to the Main Sewer Station located across from Loughlin Road, Colesville, Barlow and Loughlin Roads south of Interstate 81, the Woodhill Area, and Acre Place. The SD also includes the force mains from the Main Sewer Station to the City of Binghamton interconnection located near the intersection of Alice and Court Streets.

Sanitary sewage from this district is conveyed through a series of four (4) lift stations, manholes, gravity pipe and forced mains to the Main Sewer Station where it is eventually pumped via force main to the City interconnection.

The SD serves residential, commercial and industrial uses with 393 accounts for a total of 4,314.77 assessed units.

### **2.2 Sewer District #1 - Extension #1**

Sewer District #1 - Extension #1 serves the Corporate Drive and Link Drive area. This SD serves industrial users with 19 accounts for a combined 650.30 assessed units.

The collection system consists of gravity sewer pipe, force main, manholes and one (1) lift station. Wastewater from this district is conveyed to Sewer District #1.

### **2.3 Sewer District #1 - Extension #2**

Sewer District #1 - Extension #2 serves a single vacant parcel that was formally owned by the Universal Instruments Corporation off of Stratmill Road. This SD serves a single industrial user account with 151.48 assessed units.

The collection system consists of gravity sewer pipe, force main, manholes and one (1) lift station. Wastewater from this district is conveyed to Sewer District #1.

### **2.4 Sewer District #1 - Extension #3**

Sewer District #1 - Extension #1 serves the North Woodhill Avenue Neighborhood including Valley View Court, Gar-Glen Drive, Diana Drive, Bonita Drive and Victoria Drive. This SD serves predominantly residential users with 63 accounts for a combined 71.17 assessed units.

The collection system consists of gravity sewer pipe and manholes. Wastewater from this district is conveyed to Sewer District #1 - Extension #2.

#### **2.5 Sewer District #1 - Extension #4**

Sewer District #1 - Extension #4 serves the “New” Highland Heights Subdivision. This SD serves predominantly residential users with 55 accounts for a combined 69.62 assessed units.

The collection system consists of gravity sewer pipe and manholes. Wastewater from this district is conveyed to Sewer District #1 - Extension #2.

#### **2.6 Sewer District #2**

Sewer District #2 serves the High Street area and is comprised primarily of residential users with 8 total accounts for a combined 8.00 assessed units.

The collection system consists of gravity sewer pipe, force main, manholes and one (1) lift station. Wastewater from this district is conveyed to Sewer District #1.

#### **2.7 Sewer District #3**

Sewer District #3 serves the Colesville Road area beginning at Gary’s U-Pull It and southwest to the Stratmill Road/Corporate Drive intersection. This SD serves a mix of residential, commercial and industrial users with 41 total accounts for a combined 88.39 assessed units.

The collection system consists of gravity sewer pipe and manholes. Wastewater from this district is conveyed to Sewer District #1.

#### **2.8 Sewer District #4**

Sewer District #4 serves the Bell School area and includes the Golden St., Sommers St., Kirkwood Ave., Meadow Ln., Colton Av., John’s St., Campbell Dr., Riverview Rd., Ostrum Rd, Sunset Dr. and Circuit Dr. This SD serves residential and institutional users with 118 accounts for a combined 154.67 assessed units.

The collection system consists of gravity sewer pipe, force main, manholes and two (2) lift stations. Wastewater from this district is conveyed to Sewer District #1.

#### **2.9 Sewer District #5**

Sewer District #5 serves the River Run II Golf Link, American Pipe & Plastics, Masonite Corp., and Willow Run Foods. The SD serves industrial users with 8 accounts for a combined 418.04 assessed units.

The collection system consists of gravity sewer pipe and manholes. Wastewater from this district is conveyed to Sewer District #1.

### **2.10 Sewer District #6**

Sewer District #6 serves the Kirkwood Senior Housing Development located at the intersection of Stratmill Road and Victoria Drive. The SD serves a single multi-residential account with 33.00 assessed units.

This collection system contains no infrastructure as all sewer main and manholes were installed under Sewer District #1. Wastewater from this district is conveyed to Sewer District #1 - Extension #2.

### **2.11 Sewer District #7**

Sewer District #7 serves Monroe Tractor located on Equipment Drive off of Stratmill Road. The SD serves a single commercial account with 23.15 assessed units.

The collection system consists of gravity sewer pipe and manholes. Wastewater from this district is conveyed to Sewer District #1 - Extension #2.

## **3.0 PROPOSED DISTRICT AND GENERAL PLAN OF IMPROVEMENTS**

The proposed Consolidated Sewer District is the consolidation of Sewer District 1, Sewer District 1 - Ext. 1, Sewer District 1 - Ext. 2, Sewer District 1 - Ext. 3, Sewer District 1 - Ext. 4, Sewer District #2, Sewer District #3, Sewer District #4, Sewer District #5, Sewer District #6, and Sewer District #7 into a single district from an administrative, functional and management perspective. A map of the proposed Consolidated Sewer District is included in Appendix B. A list of parcels and boundary descriptions are included in Appendix D. The existing sewer districts all currently send wastewater to the City of Binghamton sewage collection system, no construction or other alterations within the collection systems is required for consolidation. Consolidation of these sewer districts will result in the sharing of annual operation and maintenance costs as well as capital improvement costs across a larger number of users with a standardized, transparent rate structure for all users in the new consolidated district and an equitable distribution of costs.

## **4.0 DISPOSITION OF FACILITIES**

Existing real property, sewer mains, manholes, pump stations and appurtenances in each of the eleven (11) sewer districts will remain in the operational and maintenance jurisdiction of the Consolidated Sewer District.

## **5.0 PROPOSED DISTRICT OPERATIONS**

The Consolidated Sewer District will continue to be operated and maintained in accordance with current Town policies and procedures including applicable Town and State Laws. The

collection system will continue coverage under its current Memorandum of Understanding with the Binghamton-Johnson City Joint Sewage Board.

## **6.0 REGULATORY REVIEW AND APPROVAL REQUIRED PRIOR TO CONSTRUCTION**

The consolidation of Sewer District 1, Sewer District 1 - Ext. 1, Sewer District 1 - Ext. 2, Sewer District 1 - Ext. 3, Sewer District 1 - Ext. 4, Sewer District #2, Sewer District #3, Sewer District #4, Sewer District #5, Sewer District #6, and Sewer District #7 will include compliance with 6 NYCRR part 617, the State Environmental Review Act (SEQRA).

No construction or alterations will be required for consolidation of these Sewer Districts.

## **7.0 SEWER CONNECTION FEES**

Currently the Town of Kirkwood does not charge a connection fee for a new user therefore; consolidation will not result in the imposition of any connection fees for any new or existing users.

## **8.0 DETAILED EXPLANATION OF COSTS**

All eleven sewer districts send wastewater to the Binghamton-Johnson City Joint Sewage Plant. All sewer districts currently have their own budgets for revenue and expenses. The two primary sources for revenue are special assessments and tri-annual sewer charges. The special assessments cover the operation and maintenance for the sewer districts and any budgeted capital expenses. The special assessment charged for any given property is based upon the benefit units assigned to that property. The calculation for the benefit units are detailed in the Town Code. All properties within the sewer districts are responsible for a share of the O&M costs and any outstanding debt for that district, however, only those properties connected to the sewer system receive a tri-annual bill for sewer charges.

The tri-annual sewer charges are based only on metered flow (or a flat rate for those sewer customers who do not have metered water) and cover the Town's allocation from the Binghamton-Johnson City Joint Sewage Plant (BJC). The Town's sewer rate charged to its customers mirrors the charge from BJC. Each fall, the Town receives an estimated charge from BJC for the following year to use for budgeting purposes.

Two of the sewer districts currently have outstanding debt, Sewer 3 (Colesville Road District) and Sewer 4 (Bell School District). These districts are charged secondary units on their taxes sufficient to cover the annual principal and interest on the outstanding debt. This charge is also based upon the benefit units assigned to those properties.

The Consolidated Sewer District would continue to use metered water use or a flat use rate (when there is no meter) for tri-annual billed sewer charges. Revenue for budgeted operation and maintenance, as well as budgeted capital costs, would continue to be raised through special assessments based upon benefit units.

### **8.1 Existing Sewer Districts**

The following table details the 2025 special assessment rate per benefit unit for each of the eleven sewer districts. The total benefit units per district are also provided. This annual special assessment revenue covers the operation and maintenance charges, as well as projected capital expenses.

Currently, there is a disparity among the sewer districts due to current capital improvement charges for some of the smaller and/or older districts. A consolidation of the sewer districts would result in the cost sharing of all capital improvements and would even out the rate per benefit unit such that all sewer customers would be charged the same rate per benefit unit.

Regarding the 2025 sewer rate currently being charged on the tri-annual bill, each metered sewer customer in all eleven districts is charged \$8.20 per 100 cubic feet of water used. In the absence of a metered water supply, single family residences are charged \$176.00 for each four month period. A consolidation of the sewer districts would not change this approach.

### **8.2 Proposed Consolidated Sewer District**

The consolidation of the eleven sewer districts would result in a single budget for a single sewer district in the Town. The revenue to cover the costs for operations and maintenance, and

capital expenses would continue to be raised through special assessments based upon benefit units. However, the consolidation of the districts would provide a more equitable distribution of these costs.

Both the annual budget and the day-to-day administration of the districts would be significantly streamlined through a consolidation, which would benefit both the administrative staff and the Town Board in better managing the financial operations of the sewer districts. Reporting would be more efficient and timely as expenses would not have to be periodically allocated among the eleven districts.

### **8.2.1 Debt**

The proposed Consolidated Sewer District would have no outstanding debt. There are currently two districts with outstanding debt, however, the improvements related to this debt primarily benefit the two districts alone. Therefore, the revenue to cover the annual principal and interest for the outstanding debt would continue to be raised through special assessments charged only to these two original districts. The Town Board does acknowledge, however, that with the formation of the Consolidated Sewer District, any outstanding debt would also be an obligation of the Consolidated Sewer Districts if the original districts fail to pay.

The following table details the current outstanding debt:

### **8.2.2 Assets**

Assets of the existing sewer districts and any associated extensions consist of underground infrastructure, including sewer collection piping, manholes and pump stations. These assets would remain part of the Consolidated Sewer District.

### **8.2.3 Rates**

Estimated budgets for operation and maintenance costs and capital improvements in the Consolidated Sewer District would result in a single budget and a single special assessment rate per benefit unit. This is a notable change from the current process in which each of the eleven sewer districts is charged a different rate per benefit unit.

If the eleven sewer districts had been consolidated for the 2025 Budget, the summary of revenues and appropriations would have been as follows:

This Consolidated Sewer Special Assessment Rate per Benefit Unit is in comparison to the 2025 Adopted Town Budget which included Special Assessment Rates per Benefit Unit ranging from a low of \$23.587272 to a high of \$48.770549, as presented in Section 8.1 above.

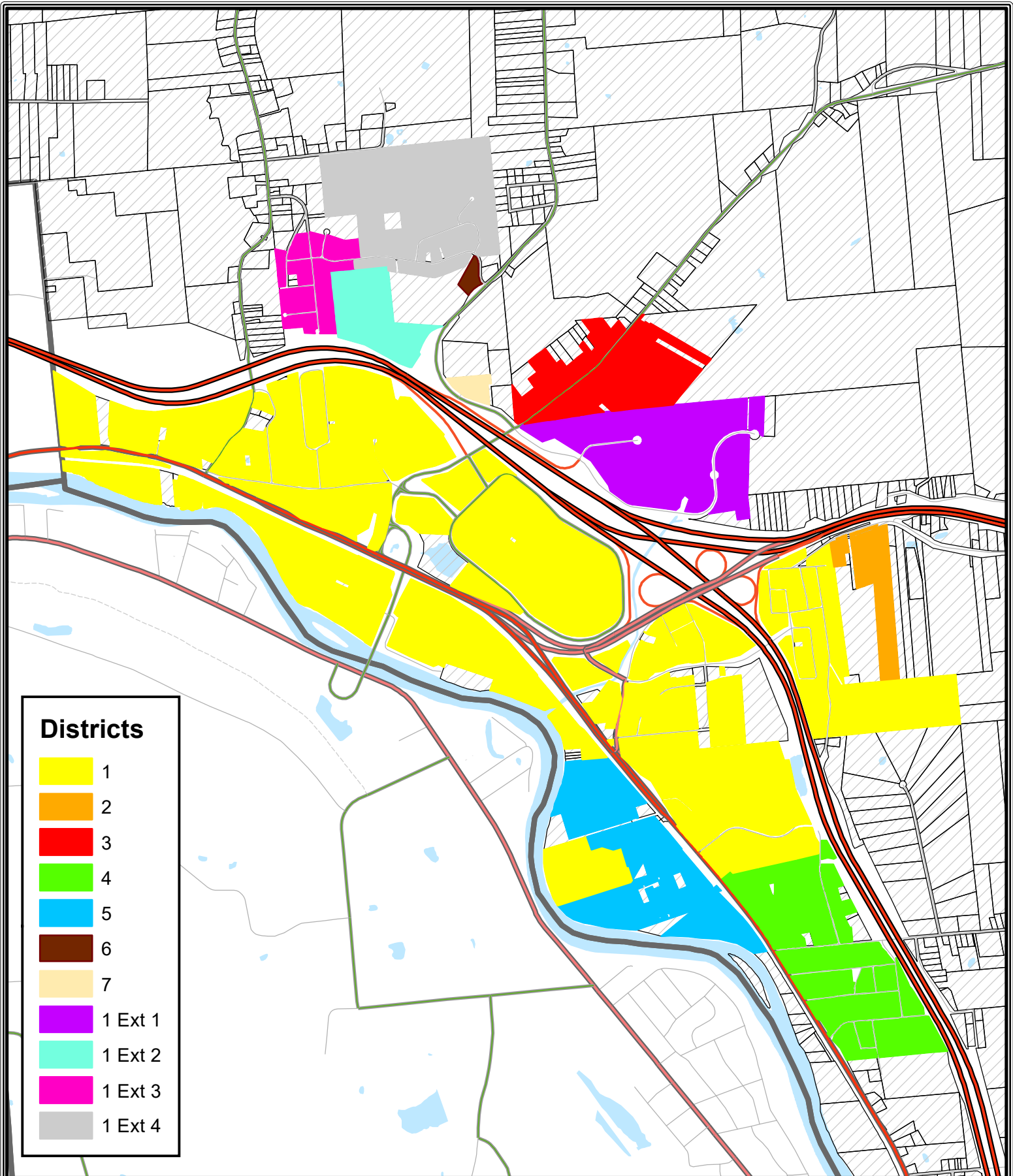
The tri-annual sewer charge, which is based upon metered flow or a flat rate where there is no meter, would continue to be the same for all sewer customers and would be calculated based upon the annual estimate provided by the Binghamton-Johnson City Joint Sewage Plant.

## **9.0     STATEMENT AS TO BENEFIT ASSESSMENT**

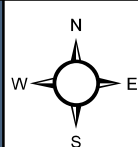

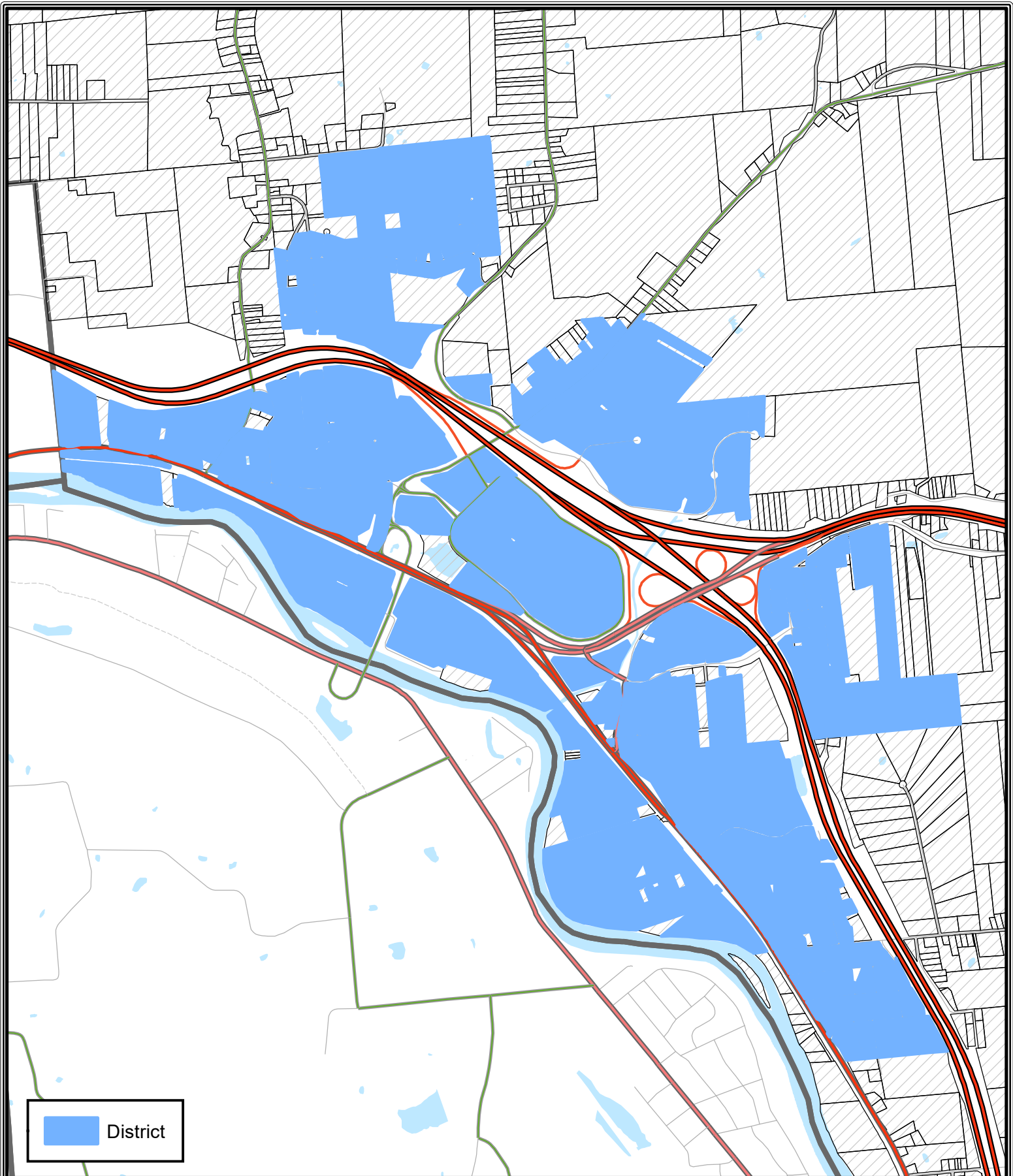

**CONSOLIDATED SEWER DISTRICT MAP**

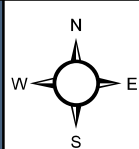

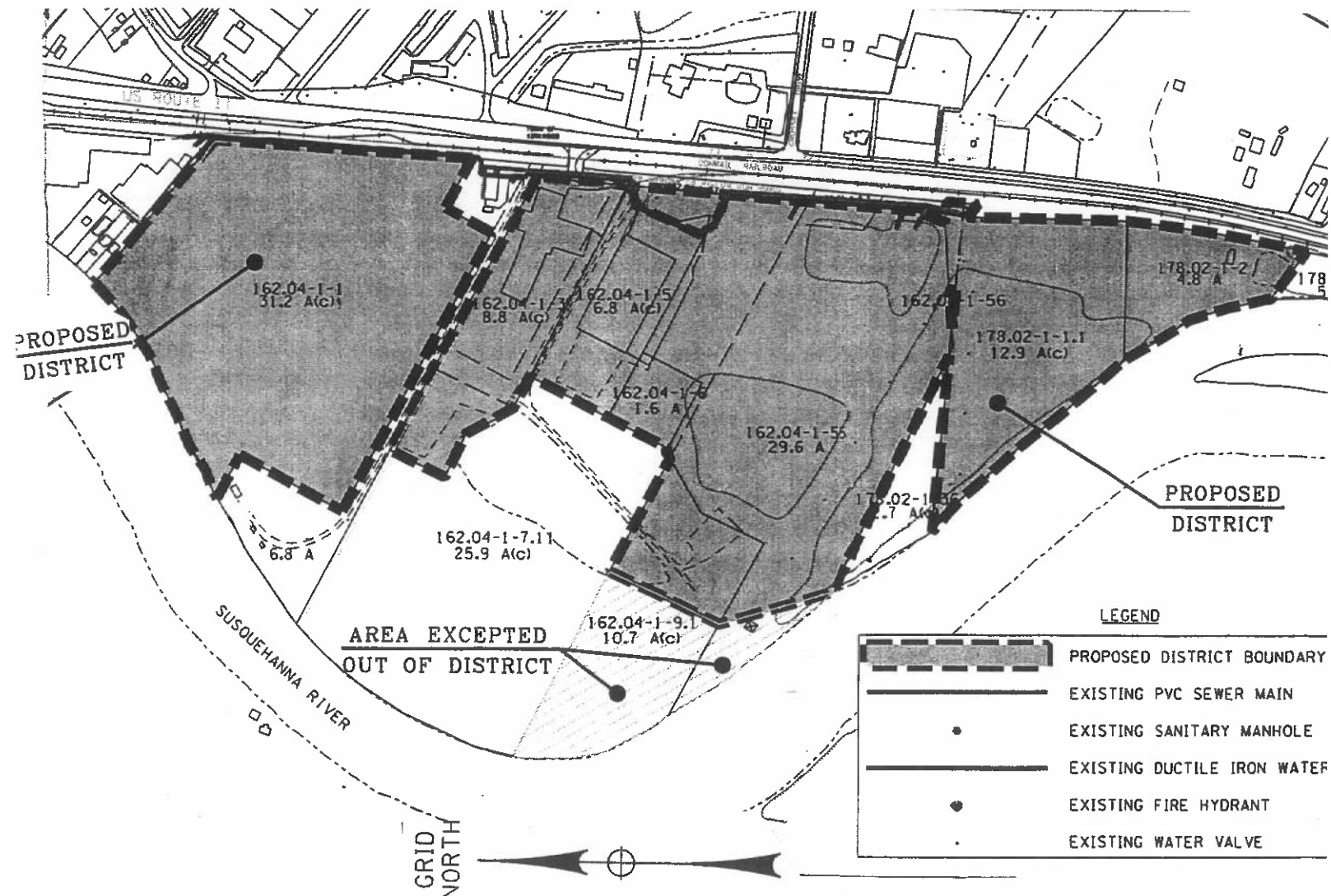
