APPROVAL OF MINUTES: March 7, 2017 Town Board Meeting

COMMITTEE REPORTS:

Meadow Lane Speed Issue.

Councilman Diffendorf reported that he received a phone call from Mark Casiuk of Meadow Lane who is concerned about the 30 MPH speed limit on that road and would like it lowered, adding there is a lot of traffic from the school. Councilman Diffendorf said he feels that is probably the proper speed limit and he is not sure if the State would lower it. It was noted there is signage. Mr. Finch said the buses are supposed to use Meadow Lane. Councilman Diffendorf said they might want to consider talking to the school about bus speed as well as employee speed, noting this is not a school zone. Mr. Finch said the issue may not be the actual speed limit but the speed people are actually going on the road. The indication is that the speed limit should be enforced, so John Finch will check with law enforcement into having radar set up in the area. He said he doesn't think it would help changing the school traffic to Riverview Road since the people living there would have the same issue with speed as the people on Meadow Lane are currently having.

Court Grant.

Deputy Supervisor Grubham reported that the Court received all of the State grant money they applied for to use for security work. They are working out the details and it will cost well below what they originally expected. Two doors will be changed and the glass in a third door will be changed to bullet proof. Another exit door will be installed in the meeting room to the driveway area because currently there are not the required number of exit doors.

Discussion: John Finch clarified for Councilman Diffendorf that the remote starter was included in the original pricing. He said it would be for the truck he will be taking home at night, adding that the sync system is for Bluetooth when he uses the truck for plowing and has to use the joy stick.

He said it will be one less truck they will have to maintain and they still have truck #38 which is an extra big truck. Since the truck is being sold to another town, Councilman Diffendorf said he feels there should be a resolution.
