Discussion – Voting Payment to County

I always had my kids call me Gordi, and nothing hits your heart more than when you are walking in Schneider's parking lot and you hear, hey Gordi, hey coach from one of your former players. While I wanted the kids to most importantly have a good time, I figured while they were there why don't they learn a little bit about baseball. But at that age kids are cute. Supervisor Kniffen told a few nice stories and memories from his coaching days that brought smiles and laughs to everyone at the meeting. Supervisor Kniffen continued by saying, it's always been close to my heart to make sure all the kids felt part of the team even if they may not have had the most athletic ability. I wanted them to say I'm one of them and not feel like an outcast. It not only pleased the kids but the parents as well.

From there I was able to get involved with the annual Christmas party. It started with Ernie Gaeta, Jim Williams, and myself. It was at the bank in Schneider's parking lot. We got a Santa from downtown and had some of the young girls dress as elves. We always had to keep the car running so we all could jump in and get warm. With the cold weather being an issue we eventually moved the Christmas party to the Town garage when John Finch, Sr. was Highway Superintendent. At that point we really improved on things because we got a real Santa and a real Mrs. Claus, and they are both here tonight, referring to Councilman Diffendorf and Pat Griffin. One year Santa was put on the roof of the Post Office and what a thrill that was for the kids.

We also had the Christmas tree lighting, one year Leslie from Country Marketplace made yellow ribbons for all the Veterans with their names on the ribbons. We would have someone that's been in the Town forever to turn the lights on the tree. That was fun.

Sometimes I wonder how I got here. When I was young I thought about getting on the Town Board. It was back when the Justices served on the Town Board and that was the year they were no longer going to do that. So, there were two openings and a lot of people running. You had to get out there and work hard. The Town Board was in the now Post Office and I sat next to Joe Griffin, Herb Kline, Ernie Travis and Art Shafer. When Art Shafer left, Joe Griffin became Supervisor. As the years rolled along I became his Deputy. He would give me good projects, and we could be celebrating Joe Griffin here tonight, that's what kind of guy he was. He gave me projects like the Bell School project and the Senior Citizen Affordable housing project, he had me present them even though he was the Supervisor. Since I did a lot of the work he wanted me to get the credit for that. He always talked with me about switching positions and I told him I don't want to be Supervisor. But, unfortunately, our friend Joe Griffin got very sick. He wanted me to take his place because I had seniority. The Town Board appointed me and that is how I got started. It gave me a whole new look at things because I was the boss. I met a lot of people along the way.

I want to take this opportunity to thank several people. Our Code department, Chad Moran is probably the best Code Officer in Broome County, he's out there all the time looking around and getting things done. I want to thank the people on the Zoning Board and Planning Board, they get paid very, very little and work nights, and their work is hard. Marchie Diffendorf has the Planning Board and Duane Travis has the Zoning Board of Appeals, a special thanks to them for what they do. Mary Kay Sullivan, my secretary, is awesome. I say a few words and she can read my mind and know what to do. We are blessed to have her. Jean Smith, who is now training our new bookkeeper, thanks to them. Jim Smith, I don't know what we would do without you. He is our financial wizard. He does a lot of complicated work for us, we appreciate you. Of course our Town Board, I appreciate them. A gal named Gayle, Gayle Diffendorf was our Town Clerk for years and we've worked together for years. Thank you for all you've done. Kelley Diffendorf is really filling in great, she's a good person and we enjoy being with her. John Finch, thanks to all your people and your secretary. Sue Glovich is a great person and does a great job. Robert McKertich, our lawyer, he came in at a bad time when the virus broke loose. So it has been a challenge and thank you so much for doing that.
